

“New Adventure Contest”

Contest Rules & Regulations

The Air Canada Vacations “New Adventure Contest” commences at 10:00 a.m. EST on May 1, 2017 and closes at 10:00 a.m. EST on May 31, 2017, (the “**Contest Period**”).

1. Eligibility

The Air Canada Vacations “New Adventure Contest” is open to all Canadian residents, having attained the age of majority according to the law of the province in which they reside, except representatives, employees and agents of The Walt Disney Company (Canada) Ltd. “**WDCC**”, Air Canada and its subsidiaries and affiliates and any of, the judges and persons with whom any of the aforementioned are domiciled.

2. How To Enter

No Purchase Necessary.

To enter, please visit www.magicalholiday.ca during the Contest Period to complete the Contest entry form and submit it as per the instructions. Required fields of entry form must be completed in full in order to make the participant eligible for a chance to win and to submit the form successfully. No facsimiles, no mechanical or manual entry form will be accepted. Each person submitting an Entry is referred to as a “Participant”. Limit of one entry per Participant.

3. Sponsor

The Contest Sponsor is Touram Limited Partnership (doing business as “Air Canada Vacations”) (hereinafter referred to as the “Contest Sponsor”). Entries received shall be deemed submitted by the authorized account holder of the e-mail address by an Internet access provider, online service provider, or other organization (e.g.) business, educational institution, etc. that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Illegible entries, bulk drop-off or mechanical reproductions or facsimile entries are ineligible.

4. Prize

One (1) Prize: One (1) Participant will be awarded the Prize consisting of a 6-day/5-night vacation package for the winner and up to three (3) guests to the *Walt Disney World* Resort in Florida (the “Prize”).

d) Up to Four (4) 6-Day *Magic Your Way* Tickets with *Park Hopper* Plus option;

e) One (1) Disney Gift Card in the amount of six hundred U.S. dollars (\$600.00 USD), subject to its terms, conditions and restrictions available here;

f) One (1) VIP Tour Guide for eight (8) hours in one (1) day (guide to be selected and subject to restrictions as determined by WDCC); and

g) VIP viewing for one (1) Disney theme park parade or show for up to four (4) persons (Parade and/or show selection and date of experience is at the discretion of WDCC. Based on availability. Restrictions apply.)

The Estimated retail value of the vacation package is \$10,732 (CAD).

All items not expressly indicated above as part of the Prize package above are excluded including the following exclusions:

Reservations are subject to complimentary allotment and may not be available even if rooms and/or air are available on the brand specific website or through another travel partner.

Flight schedules and hotel accommodations are subject to change without notice or compensation. Air Canada Vacations and The Walt Disney Company (Canada) Ltd. reserve the right to relocate the winner from his/her hotel of choice to an alternate resort within their chain or to alternate dates based on availability or in the event the destination and/or hotel is no longer offered.

8. The Contest Sponsor will attempt to contact the potential winner by telephone or email within three (3) business days after the draw. Proof of identification must be provided upon request. In order to be declared a winner, the potential winner must first correctly answer, unaided, a time-limited mathematical skill-testing question.
